For Programme Directors/Coordinators/Supervisors:

I want to propose a Standard Residency Training Programme (SRTP) as a Programme Director

Please fill in the application form "srtp_appl_director_2019" (including signatures) and send it to the Chair of the EdCom together with the description of the frame of the programme as outlined in the guidelines ("srtp_annex_2019").

I want to propose an Alternative Residency Training Programme (ARTP) as Supervisor Please fill in the form "artp_appl_2019" (including signatures) together with the Candidate and send it to the Chair of the EdCom, together with the full description of the programme as outlined in the guidelines ("artp_annex_2019").

For Residency Candidates:

I want to apply for becoming a Resident

Please fill in the form "INIT_REG_2019" for initial registration (including signatures) and send it to the EVPC Secretary together with your CV (suggested format: Curriculum vitae format) and your license to practice as a Vet in the EU (or an informal application for dispensation from this requirement). This waiver must be provided with the actual application. If you are a graduate from a Vet School that is not approved by EAEVE you also need to apply for a waiver for this requirement. This is included in the initial registration form as well (no additional documents required as information on your professional education should be contained in your CV).
